

#### Our projects, experimental labs

Worldwide | Survey on occupational health of education personnel The ESN conducts international surveys on the occupational health of education personnel to take stock of challenges, do advocacy and to identify new avenues for cooperation. In 2017, the ESN carried out a survey in 15 French-speaking countries, in collaboration with the CSFFE.

Worldwide | Awareness workshops and training on social protection The ESN proposes the organisation of participatory workshops to mobilise and raise awareness in civil organisations about the principles and challenges of solidarity-based social protection and healthcare coverage.

Europe | Promoting health and well-being in school The ESN is working on promoting and implementing a programme for assessing and promoting students' well-being. FILGOOD, developed in France by MGEN, assists education professionals in collaborating with young people to identify and develop health promotion and well-being activities.

Burkina Faso | Creation of a mutual health fund The ESN is working with several unions in Burkina Faso to create a health mutual fund to improve access to healthcare for all education professionals and their families, and thus allow the continuity of professional activity, which guarantees the quality of teaching.

Haïti | Health promotion for the education community The ESN is working alongside the educational community of Port-au-Prince on the SACHA project, which aims to improve the learning and teaching conditions in six schools with an innovative and participatory health promotion programme.

Colombia | Mobilising young people around social protection and solidarity The ESN and its Colombian partners have developed a pilot programme for education on social protection and the social and solidarity economy (SSE). Consisting of both theoretical and practical modules, the programme aims to position the SSE as an alternative development model.
